**Update on the Darien Quarry Permit Application:**

The Ministry of Natural Resources and Forestry continue to work with Darien Aggregates Inc. and their consultant, Tulloch Engineering, to fulfill the Aggregate Resources of Ontario requirements of a permit application on 'Crown Land' under the Aggregate Resources.

The proponent remains in the **Resolution of Concerns stage of the Category 12 application**. Revised site plans have recently been submitted to the ministry, but have not yet been made available to the public.

Key concerns are the complex water management system that will be required for the lifetime of the quarry (120 years); impacts on wetlands, surrounding waterways, and the Serpent River Watershed; the loss of moose aquatic feeding areas and species at risk, particularly one of the densest documented populations of endangered Blanding's turtles in the province; a rehabilitation plan that has never been attempted on this scale (2 man-made lakes that could take up to 400 years to fill naturally, up to 75 years by pumping from neighbouring water bodies).

It is our understanding that the MNRF also has concerns that need to be addressed. Once the applicant feels that they have addressed all of the ministry's concerns, they will submit a project evaluation under the Class EA that will explain their process.

As part of the Aggregate Application process, Darien Aggregates was expected to consult with local Indigenous communities: Mississauga FN, Serpent River FN and Sagamok Anishnawbek FN, as well as Metis Nation of Ontario. This consultation process is not yet complete.
